# CISG LEGAL TRAINING WORKSHOP

## Essential Know-How for Lawyers

The United Nations Convention on Contracts for the International Sale of Goods [CISG] is expected to be implemented in Hong Kong in around the third quarter of 2022, subject to completion of the relevant process under Article 153 of the Basic Law as well as requisite formal notification by the Central People's Government to the Secretary-General of the United Nations (as depositary for the CISG) for applying the CISG to the HKSAR. To prepare legal practitioners for the implementation, the Department of Justice and Asian Academy of International Law join hands to organise a two-part legal workshop, in which renowned CISG experts will give participants an in-depth analysis of the main provisions of CISG, as well as practical tips for lawyers on contract drafting, dispute preventions, etc. that are useful for advising on cross-border sale of goods transactions in light of CISG.

**LAI, Adrian**  
Deputy Secretary General and Co-Convenor of the Advisory Board  
Asian Academy of International Law

Adrian is a practising barrister in Hong Kong; he is also a Certified Public Accountant of Hong Kong and holds the specialist qualification in insolvency matters. Adrian maintains a predominantly civil practice and has been engaged as Counsel on matters relating to arbitration, banking, commercial, company, construction, professional accountants/auditors' negligence and professional disciplinary proceedings. Through practice, Adrian has developed a wealth of experience and expertise on arbitration matters. He is on the Panel of Arbitrators of Hong Kong International Arbitration Centre and has been appointed as sole or co-arbitrator on international commercial arbitrations. Apart from sitting as an arbitrator, Adrian has been engaged as Counsel to advise or appear in international or domestic commercial arbitration, investor-State arbitration and State-State arbitration. Insofar as arbitration-related litigations are concerned, he appeared as Counsel on important cases such as *FG Hemisphere v Congo*, *Pacific China Holdings v Grand Pacific Holdings*, *Shandong Hongri v Petrochina Int'l*, *S v B*, *Re Insignia Technology*, *Gongbenhai v HKIAC* and *TNB v China National Coal*. He is often invited to speak on topical issues of arbitration. Adrian maintains an academic interest in international law. He graduated with a Master's degree in Public International Law and also attended The Hague Academy of International Law.

**SCHROETER, Ulrich G.**  
Professor of Law  
University of Basel, Switzerland

Ulrich Schroeter is Professor of Law at the University of Basel, Switzerland. He has published extensively in the fields of contract law, international trade law, arbitration, treaty law, commercial law and financial markets regulation. Ulrich's research has been cited by courts worldwide including in Australia, Austria, Germany, the Netherlands, Switzerland and the USA as well as by Advocates General at the European Court of Justice. One area of focus for Ulrich's research is the 1980 Vienna Sales Convention (CISG). He is the co-editor of *Schlechtriem & Schwenzler: Commentary on the UN Convention on the International Sale of Goods (CISG)* (5<sup>th</sup> ed., Oxford University Press, forthcoming 2022) and has written the leading German textbook on the CISG, *Internationales UN-Kaufrecht* (Schroeter, 7<sup>th</sup> ed., Mohr Siebeck, forthcoming 2022). Ulrich serves as the national correspondent for Switzerland to the United Nations Commission on International Trade Law (UNCITRAL) for the CISG and is a member of the CISG Advisory Council. He regularly advises on CISG matters. Ulrich was educated at the Albert-Ludwigs University of Freiburg, Germany, and the University of Lausanne, Switzerland. He received his *Doctor iuris* from the Freie Universität Berlin.



**KRÖLL, Stefan**  
Professor of International Dispute Resolution  
Bucerius Law School, Hamburg

Stefan Kröll is Professor of International Dispute Resolution at Bucerius Law School in Hamburg and also one of the directors of the Willem C. Vis International Commercial Arbitration Moot. He is Germany's national correspondent to UNCITRAL (United Nations Commission on International Trade Law) for arbitration and one of its leading arbitration experts. Stefan has acted as arbitrator in over 95 cases under many different arbitration rules and including arbitrations with State parties. He is a member of the board of directors of the German Arbitration Institute, member of the advisory boards of the Vienna International Arbitral Centre as well as the Arbitration Institute of the Finland Chamber of Commerce. He also sits on the advisory boards of several journals on arbitration and international contract law. Stefan has published widely in the field of international arbitration and international sales law and regularly lectures on these topics in universities all over the world.
