## THE 2025 ICC-HK INTERNATIONAL COMMERCIAL MEDIATION COMPETITION

**NOVEMBER 24 - 27, 2025 HONG KONG**

### About the Competition

We are thrilled to announce that Hong Kong will be hosting the 2025 ICC-HK International Commercial Mediation Competition in November 2025 (the “**Competition**”). The Competition will take place from 24 to 27 November 2025, organised by the International Chamber of Commerce - Hong Kong (“ICC-HK”) and the Hong Kong Department of Justice (TBC). The Competition aims to provide students with opportunities to develop valuable skills in mediation and mediation advocacy—essential competencies for modern dispute resolution in an increasingly multi-cultural and global marketplace.

This year’s event follows the successful experiences in 2018, 2020, and 2024, where more than 20 teams from various jurisdictions around the world competed. Once again, teams from local and regional universities, together with counterparts along the Belt and Road and beyond, are invited to join.

Some funding will be provided to the winning team to support their participation in the competition at ICC Global Headquarters in Paris, France in February 2026.

**University Teams** of 2-4 students are invited to apply.

**Professional Mediators** are invited to apply to volunteer as judges, mediators and Competition case authors.

**Helpers** are invited to volunteer and assist with the event.

### Rules & Procedures

The rules of this Competition is based on the world-famous ICC International Commercial Mediation Competition Rules, allowing students to exhibit their mediation skills in realistic mock commercial disputes drafted by seasoned professional mediators.

Teams of 2-4 university students will compete through a series of rounds. Each team will represent a party in a dispute, with members assuming the roles of Client and Counsel. A qualified professional will mediate the dispute, while a panel of distinguished judges assesses how well the teams advance their interests towards a settlement.
