Dr Lee also serves as a member for the Basic Law Promotion Steering Committee, Convener of the Working Group on Teachers and Students, and Chairperson for the Standing Committee on Values Education of the HKSAR Government, Convener of the 'Hong Kong in the Belt and Road Initiatives' Study, State Council of the Chinese Government, and part-time researcher at the School of Law of Tsinghua University. As one of the nation's young academic, Dr Lee's interests include Hong Kong Basic Law, Chinese legal system and constitutional law. Dr Lee also served as a consultant to the Harvard Law School (Program on International Financial Systems), Visiting Fellow (2013) at the CCPL, Faculty of Law of The University of Hong Kong, Deputy Governor in the Xifeng County of Guizhou Province, Deputy Executive Director of Our Hong Kong Foundation. He is Visiting Professor of Law of The Chinese University of Hong Kong, Honorary Professor of Law of The University of Hong Kong, and Adjunct Professor of Law of the China University of Political Science and Law in Beijing. He is Sentencing Editor of *Hong Kong Cases* and *Archbold Hong Kong*, and co-author of *Sentencing in Hong Kong*.
